

## Appointment of Corporate Advisor to assist development strategies for NiWest Nickel Cobalt Project.



**GME Resources Limited (“GME” or “the Company”)** is pleased to advise the appointment of **Somers & Partners (Somers)** to provide corporate advisory services in relation to the Company’s 100% owned NiWest Nickel Cobalt Project (the “**Project**”).

**Somers** have been mandated to examine and assist with, funding arrangements, development of strategic options and alliances, market research and provide corporate advice to maximise the value of the Project for shareholders.

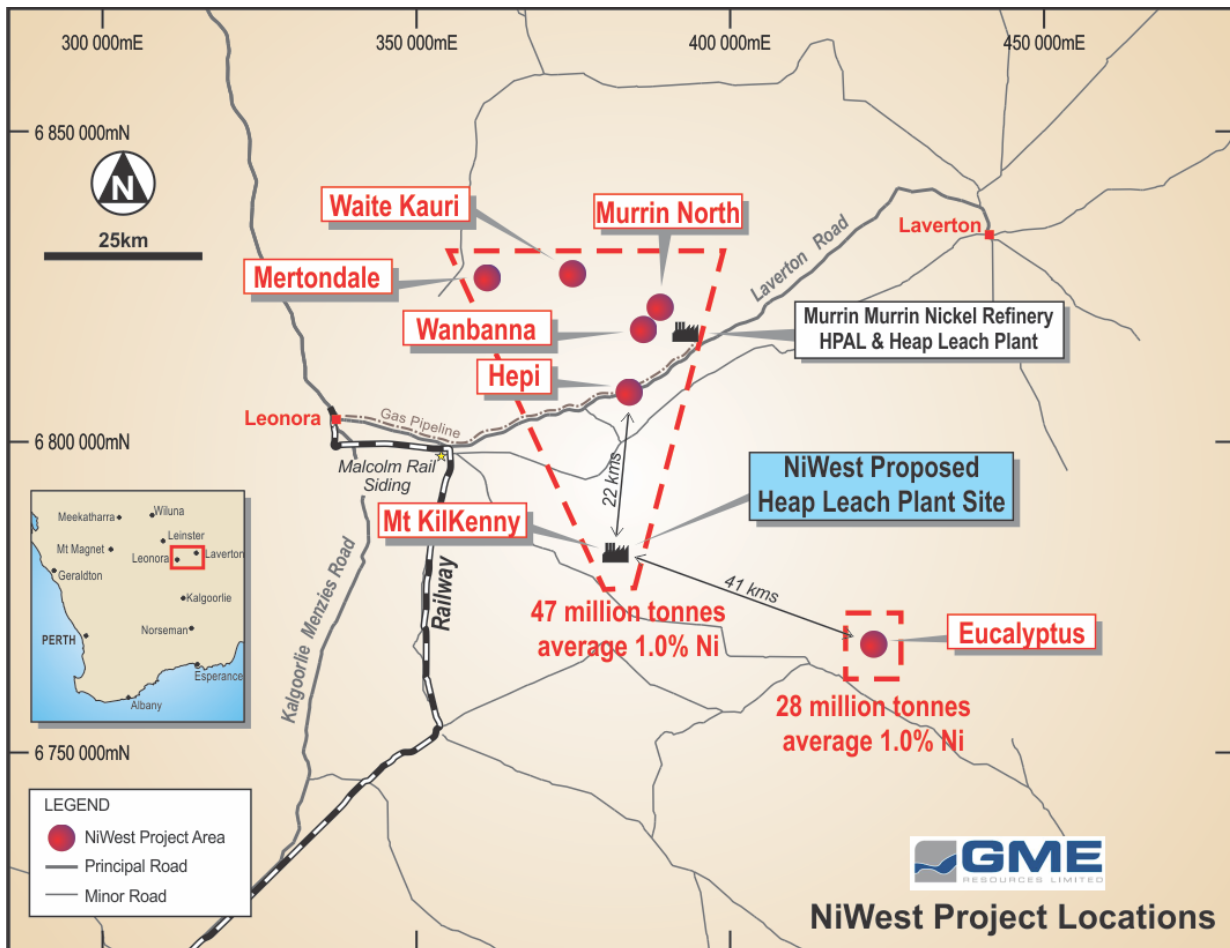


Figure 1 NiWest Nickel - Cobalt Laterite Project location plan

The Project, located adjacent to Glencore’s Murrin Murrin Nickel Refinery in the North Eastern Goldfields of Western Australia (Refer Figure 1), hosts one of the largest undeveloped Nickel and Cobalt resources in Australia estimated to contain 81 million tonnes of nickel at 1.03% and 0.06% Cobalt (refer Table 1 and ASX announcement NiWest Resource Update 21 Feb 2017).

The Project is at an advanced stage and will be development ready on completion of the DFS metallurgical test program that aims to establish the optimal flow sheet design for a heap leaching operation coupled with a direct solvent extraction and refining facility capable of producing nickel and cobalt sulphates for the high growth lithium-ion battery market.

A significant body of work has already been completed in relation to leaching kinetics, metallurgical and geotechnical conditions, environmental surveys and reports, water resources, mining schedules and other aspects related to developing the Project. The Company recently announced an updated Resource estimate to comply with JORC 2012 standards with approximately 75% of the Resource reported in Measured and Indicated categories.

In order to align Somers with shareholders, commercial terms for the 12 month contract will be satisfied by the issue of 2,000,000 ordinary fully paid shares, of which 1,000,000 shares will be escrowed for a six month period. Somers is an Australian investment bank focussed on resources and emerging companies. Recent clients of Somers include Panoramic Resources, Resolute Mining, Triton Minerals, Horizon Gold and Bligh Resources.

The Company looks forward to working with Somers in assisting the Company fast track development of the NiWest Nickel Cobalt Project.
