Notification under Section 708AA (2) (f) of the Corporations Act 2001

GME Resources Limited ('GME' or the 'Company') advises that it has today issued 5,317,847 fully paid ordinary shares at an issue price of \$0.055 per share, being the shortfall of the Renounceable Entitlement Offer announced to ASX on 5 April 2019 (the **Entitlement Offer**).

GME confirms that pursuant to section 708AA(2)(f) of the Corporations Act 2001 (Cth) (Corporations Act) that:

1. GME has today issued 5,317,847 fully paid ordinary shares being the shortfall of the Entitlement Offer without disclosure to investors under Part 6D.2 of the Corporations Act.
